**UPDATE ON THE CLOSURE OF REGISTER OF MEMBERS  
IN RELATION TO THE 2024 SECOND EXTRAORDINARY GENERAL  
MEETING**

Reference is made to the notice of the 2024 second extraordinary general meeting of Shandong Chenming Paper Holdings Limited\* (the “**C m a**”) dated 29 September 2024 (the “**N t c EGM**”) in relation to the 2024 second extraordinary general meeting of the Company to be held on Wednesday, 16 October 2024 (“**EGM**”). Capitalised terms used herein shall have the same meanings as those defined in the Notice of EGM, unless the context requires otherwise.

Holders of H shares of the Company or their proxies whose names appear on the register of the Company on Wednesday, 16 October 2024 are entitled to attend the EGM by presenting their identity documents.
